Puppy is defined here to be an Alaskan Malamute puppy which is in good health at the time of transfer. The puppy is pure bred and can be registered with the American Kennel Club (AKC).

The breeder guarantees the above-described puppy to be healthy at the time of sale.

It is the Breeders goal to produce healthy, sound puppies. We breed dogs that are only pure bred Alaskan Malamutes and with any dogs we plan to breed, we do our best to research their ancestors looking for any genetic defects, that could be passed on. We also raise our puppies in what we believe is the best way possible in regards to diet, exercise, socialization, and veterinary care.

There are many factors that can influence the growth and development of the puppy, such as diet, exercise, weight gain, etc. The Buyer assumes the responsibility to carry on with these for the healthy growth of the puppy.

_____All appropriate shots for the puppy's age have been given, and a record of the vaccination history has been provided to Buyer.

The Breeder does not assume any liability for any injury to puppy after delivery/pickup.

The Buyer agrees to have this puppy examined by a veterinarian within 96 hours of delivery/pickup or all guarantees will be null and void.

If the puppy is found to be other than healthy by the buyer's veterinarian, it shall be returned to the breeder immediately, and the purchase price will be refunded. Deadline for this refund is 72 hours after time of the buyers veterinary check.

Breeder does not pay for any vet bills when the puppy is in the hands of the Buyer. The Buyer accepts responsibility of all vet bills during the duration of the

puppy's life.

The Buyer agrees to maintain the puppy's health in good condition, and to provide yearly examinations, vaccinations, heart-worm tests, and any other usual procedures necessary to assure good health of the puppy or all guarantees will be null and void.

This Puppy has a 2 year guarantee against genetic defects causing death. In case of puppy's death, the Breeder will replace the puppy/dog with a puppy of equal value at earliest convenience. All veterinary records are required to be sent to the Breeder prior to any replacement, for the Breeders veterinary to review.

The Breeder can offer no further guarantees once the care of the puppy is no longer under the control of the Breeder.

_____ Limited Registration: The Buyer agrees that this puppy will not be used for breeding purposes, and will spay/neuter the puppy when it reaches the appropriate age (12-18)months to have the procedure done.

_____ Full Registration: The Buyer agrees that neither he/she nor the Buyers estate/executors may sell this puppy or transfer ownership of this puppy without the Breeders knowledge and written consent. If you purchase full registration and then are unable to keep your puppy and choose to sell it, the puppy's registration may not be transferred.

No puppies purchased with full registration may be sold without full and written consent of North Shore Alaskan Malamutes (Breeder).

additionally the health garentee will be voided if ,

Buyer breeds puppy before the age of 18 months.

The Breeder does not guarantee fertility on puppies sold with full registration.

The Buyer agrees that if at any time the Buyer cannot take proper care of the puppy, the Buyer must contact the Breeder and the Breeder will have the first choice to either

1. Take the puppy back, or
2. Assist the Buyer in finding a suitable home for the puppy.

The Buyer agrees to notify the Breeder of any changes of address during the puppy's lifetime.
